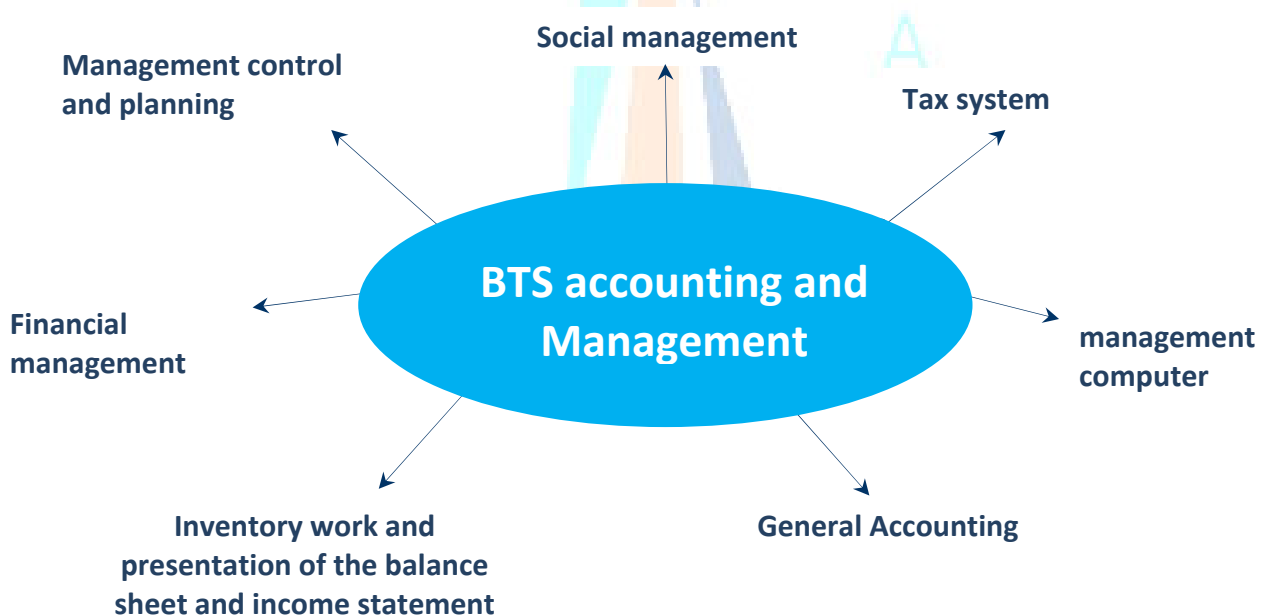
Who is this BTS for ?

All types of applicants can be admitted in BTS AM :

- general high school graduates (S or ES)
- equivalent in sciences and management technologies,
- Bachelor graduates with a professional degree.

Skills developed in the course of training

The BTS AM develops multiple professional skills :



Internships

During the two years of study, the 10 weeks internship allows the students :

- to reinforce skills through practice,
- to gain experience,
- to help define the professional project.

1st year	6 weeks in May-June
2 nd year	4 weeks in November-December

It can be realized in a company, an accounting firm, a management centre, an association ...

What studies to pursue?

The BTS AM serves more and more often as a springboard to pursue studies in either initial training or alternatively :

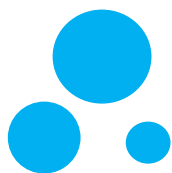
- DCG (Diploma in Accounting and Management),

To which professions?

The BTS AM offers a wide variety of jobs :

- accountant or management assistant of a SME/SMB,
- associate or assistant accountant in accounting firm, or in Management Centre,
- after pursuing studies and a few years of experience, it is possible to hold positions of accounting or financial managers or to become an accountant.
